## INFORMATION UPDATE AFFIDAVIT

I Smt. Sonali Gupta daughter of Dr. Chander Prakash Malik aged about 52 Years, presently working as Principal cum Member Secretary, Board of Trustees of Indian Language School, Lagos, Nigeria, managed by the Trustees of Indian Language School, Lagos, Nigeria, do hereby solemnly affirm and sincerely state as follows:

1. That the Indian Language School which has been established by the Indian Community and the High Commission of India in Lagos, Nigeria.
2. The School comes under the umbrella of the High Commission of India in Nigeria.
3. The objective of the Indian Language School (hereinafter called "the School") shall be to impart holistic and inclusive education at the Primary, Secondary and Senior Secondary levels (LKG to Class XII) and to prepare students for examinations under the Central Board of Secondary Education, New Delhi, India.
4. The School aims at being a total non-profit-making establishment, offering affordable, quality education to the children of the Indian community in Lagos.
5. The income and properties of the School shall be applied solely towards the promotion of the objects of the School as specified in these Rules and Regulations/Constitution.
6. The School shall be governed at all times by the decisions of a majority of the Board of Trustees, which body shall consist of 18 (Eighteen) members in addition to the Chairman.
7. That the Principal and Correspondent/Manager of the School have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time.
8. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the school will ensure that sufficient number qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

12. That the school will not coerce any students/parent to buy books/stationery/uniform from any particular shop.
13. That the school shall strive to make efforts for conservation of environment.
14. That the school will ensure that the school fulfils all essential requirement before applying for affiliation and will fulfil all other conditions post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time.
